3. The name of the school has been changed only once for administrative reasons. If a proposal for change is submitted again, it will not be allowed to be considered.
4. The school management should not be conducted the school in the old name for any reasons
5. The newly renamed name shall prevail from the date of change of school name for office affairs.
6. Regarding the school running in the new name, The Block Education Officers immediately from date of commencement of change of school name shall inform this office in writing,
7. Instruct the Governing Body to bring the change of name to the notice of the public in the local newspapers and inform the public about the previous name change in the same publication.
